Chief's Report for June 4th, 2020

Thursday, May 21st

- Town 10am Conference Call, 183 Covid-19 cases, 14 deaths
- Fire Prevention Grant was submitted to FEMA for \$14,000
- I was notified by a member of the Department that his wife had tested positive for Covid-19 and that he was going to get tested as well as another member who also was a direct contact.

Friday, May 22nd

• The member of the Department stated that he had tested positive for Covid-19 and was in quarantine. The other direct contact Department member had tested negative and would self-isolate.

Saturday, May 23rd

 5 Department members who had direct contact with the Department member who tested positive for Covid-19 went and got tested and were placed in quarantine until the test results were received

Monday, May 25th

- Memorial Day!
- Structure Fire at 10 Parker Drive, two minor civilian injuries, all Department Members did an amazing job.

Tuesday, May 26th

 All 5 Department personnel in quarantine received negative test results for Covid-19 and were allowed back to work.

Wednesday, May 27th

- Received the AM Radio transmitter and associated equipment for use at District meeting... there was a reason it was only \$164 bucks. Went to plan B and contacted Steve Ruiz for assistance with District Meeting.
- Mr. Ruiz stated he would assist us with a P.A. system for the meeting.
- Issued Memo to Department personnel, informing them of the changes at District meeting and why the decision was made to withdraw the articles that the Fire Department submitted.
- Working Brush Fire, Lisa Lane (White Island), ¾ acre all personnel did a fantastic job

Thursday, May 28th

- Received the ISO (Insurance Services Office) report for the Wareham Fire District and
 I'm happy to report we went from a 3.9 classification to a 2.2 classification. I believe a
 lot of the difference came from the records that Andy Reid produced for the Water
 system, so, many thanks to him and our reporting system as well.
- Began work on the proposed idea for holding District meeting at the High School parking lot.
- Recruit Call Firefighter Nathan Giron informed me that he would be leaving the
 Department and enlisting in the Army as of July 13th. I want to wish Nathan the best in

- During the Town Conference call, Wareham Police advised of a Vigil to held at the High School track for "Black Lives Matter' and also a Protest March that will be Saturday, June 6th starting at Onset Beach and going to the Police Station. The Police Chief strongly advised to have a plan in place.
- An Incident Action Plan (IAP) was developed and distributed to the Department for review in preparation for the Black Lives Matter protest march on Saturday, June 6th.
- Meeting with Steve Ruiz and he stated he will have a full P.A. system with multiple microphones available for District Meeting.
